Colombia produced 1.17 million 60-kg (132-lb) bags of washed arabica coffee in June, up 23% on the same month last year, the National Coffee Federation said on Thursday. Production in June 2023 was 956,000 bags. Exports in June were up 36% at 1.03 million bags, from 753,000 bags a year earlier.

Colombia reported exports worth \$4.45 billion in May, down 1.1% year-on-year, the government's DANE statistics agency said on Thursday.

Mexican President-elect Claudia Sheinbaum named Omar Garcia Harfuch to be her security minister in a bid to repeat the successes in fighting crime she had as mayor of Mexico City. Harfuch, who served as Sheinbaum's security chief when she ran the capital from 2018 to 2023, was credited with halving the homicide rate in the city.

Hurricane Beryl churned over the Cayman Islands on Thursday as it took aim at some of Mexico's top tourist resorts, after belting Jamaica with winds that uprooted trees and tore apart buildings.
